

# Instructions for use

#### Intended Use

The flexible disposable cytology brush consists of brush head, tube, bend protection and handle.

Disposable cytology brushes are intended to take tissue samples for cytological examination.

The instruments can only be used under an endoscope. These instruments are not meant for any other purpose!

#### Do not operate with damaged instruments!

This manual should only be an aid to help the user to correctly use disposable cytology brushes to guarantee safe procedures and avoid unnecessary risks for the patients.

#### 2. Types

Endoaccess GmbH offers single-use Cytology Brush in two different designs, lengths and diameters for different types of endoscopes.

# Disposable Cytology Brush STERILE EO



#### Cautions 5.

- Keep away from moisture
- Refer to package label for minimum channel size required for this
- In the event of inadequate sterilization due to reuse or reprocessing of the product or intolerance to a product component, infection or injury to the patient may occur.
- After use, dispose of products and packaging in accordance with hospital, administrative and/or local government policies.
- Do not use the device if the packaging or the surface of the device is damaged

#### Contraindication

- To be used only by professional surgeons
- Do not use this device on patients if the surgery might for any reason endanger the patient's life
- As far as possible avoid any of unsafe situations for patients while using this device.

#### Operation

#### 7.1.Insertion:

Retract the brush completely into the Teflon tube before inserting into the operating channel. Please observe the compatibility between the cytology brush's tube and the endoscope's working channel diameter (see catalogue).

# 7.2 Avoid bending:

- Extend the brush completely by pushing the handle
- Place the brush in front of the tissue to be sampled
- Retract the brush completely into the tube by pulling the handle

#### Sterilization

Disposable cytology brushes are delivered sterilized by ETO gas. For single use only. To be disposed of after use according to hospital guidelines.

# Period of validity of sterilization is three years

#### Storage

Products are not to be stored under heavy pressure to avoid deformation.

- Store in clean and dry environment
- Avoid direct sunlight

Do not put any objects onto the instrument or its package! Do not store the instruments near any aggressive chemicals! Do not expose the instruments to direct or indirect sunlight or other ultraviolet rays!

Improper storage voids all warranty claims.


